Currently, we have two pipes of 50Mbps each into the district contracted through Western Suffolk BOCES. We have never peaked on either pipe, and have used it for redundancy purposes, but with our direction to include more devices, and going one-to-one, we will be adding more access. In 2016-2017 we have signed a COSER with Western Suffolk BOCES to increase both pipes to 100Mbps to accommodate our 1,600 students.
